Your Leadership Gift Makes a Great Impact in Brown County.

Leadership Giving is an opportunity for donors to play a leadership role in strengthening our community and to be recognized for making a significant financial commitment to Brown County United Way. Leadership levels of giving are as follows:

Tocqueville Society: Recognizes individual or combined gifts of \$10,000 or more

Leadership Circle Society: Recognizes individuals or combined gifts of \$1,000 - \$9,000 at the following levels:

Bronze level: \$1,000 - \$2,499

Gold level: \$5,000-\$7,499

Silver Level: \$2,500-\$4,999

Platinum Level: \$7,500-\$9,999

Restrictions on Designated Gifts

Donors can direct a portion or all of their gift to a specific agency of their choice. A recipient organization must be a nonprofit 501(c)(3) organization, excluding churches, political organizations, and governmental entities. Donors must pledge a minimum gift of \$26 to each agency designee.
